Countryside Stewardship scheme open to applications

As you are probably already aware, Countryside Stewardship 2021 opened for applications this week. More information is available here: https://www.gov.uk/government/collections/countryside-stewardship-get-paid-for-environmental-land-management

Mid tier, Wildlife offers, Higher tier, Capital grants, Woodland support grants are all open as of the 9th February. Closing date for Higher tier and Capital grants is 30 April, Mid tier and Wildlife Offers closes 30 July.

As members of this group you can receive a 20% 'uplift' in your points score for Mid tier with an endorsement form from Sarah. We as a team are also available to help with Boundary grant application, we can provide you with maps and photographs as required in your application.

Future of the Pendle Hill Farmers Network

The Pendle Hill farmer Network has been running since April 2018, and is currently set to close at the end of March 2021. However, there is the chance of an extension for another 12 months, and we would like to take this up.

We need to have at least 2000ha of coverage in order to apply for this additional year. Many thanks for all the replies we have had so far, we are around 400 ha short at the moment, so if you would like to stay involved and have not yet had a chance to return your slip, we would be very grateful if you could fill it in and return it.

Pendle Hill Boundary Restoration Scheme

We have three more hedgerow restoration lengths going ahead this winter, as well as another stretch of walling in the spring. This means that we have reached capacity in the budget available, but we will be seeking further funding, as the scheme has proved so popular with members.
