Soil Sampling still available

James Bretherton is speaking at our February meeting about soil health and in particular about the importance of soil carbon. There is still time to have three fields sampled to determine the amount of carbon currently stored in the soil. Carbon storage is going to become an increasingly important element of support packages in the future (e.g. ELM), and so this is a great opportunity to see how much carbon your soils are currently storing. We would recommend you select three different types of grassland on your farm according to the types you have, for example improved silage ground, pasture, low input grassland, species rich meadows, upland pasture or hill ground. Once you have selected the fields you would like sampled, please let Nichola know and one of us will come and take the samples for you. You have until the end of February to let us know so that the samples can be analysed before the end of our Facilitation Fund agreement at the end of March 2022
